




## Section I. Invitation for Sealed Quotation

Sealed Quotation Forms may be purchased by eligible Suppliers/Bidders 24/01/2075 onwards on the submission of a **Written Application**, copies of **Company/Firm Registration** and **VAT Registration** certificates and upon payment of a non-refundable fee of **NRs. 1,000.00**. The Sealed Quotation Document shall be available for sale up to office hours till 07/02/2075.
4. Sealed Quotations must be submitted to the above office on or before **12.00 Noon** on 08/02/2075. Quotation received after this deadline shall not be accepted.

Quotations must be valid for a period of **45 days** after opening of Sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to **NRs. 18,500.00 (In Words: Eighteen Thousand Five Hundred Rupees Only)**, which shall be **valid for 75 days** after opening of the Sealed Quotations.
6. If bidder wishes to submit the Cash Security, the cash should be deposited in Bank Account No. **06703000000003000005** at **Nepal Bank Ltd, Phidim Branch** and submit the original receipt of the deposited amount of cash along with the Sealed Quotation.
