- 1. Yangwarak Rural Municipality has received a grant from GoN towards the cost of Construction of Oyam Brihat Khanepani Aayojana and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Oyam Brihat Khanepani Aayojana and YRM/NCB/Works/No-02-2080/081. Bidding is open to all eligible as per Section V of bidding document.
- 2. Yangwarak Rural Municipality invites electronic bids from eligible bidders for the construction of Oyam Brihat Khanepani Aayojana under National Competitive Bidding -Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 1,07,00,000.00
  - Minimum Work experience of similar size and nature: I number of project and value of each project Nrs. 1,27,9,500.00
- 3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system www.bolpatra.gov.np/egp.
- 5. A complete set of Bidding Documents may be purchased from the office *linsert name and* address] and the office [insert name and address] by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of [Insert amount] till [Insert date] during office hours.

Eligible Bidders are requested to submit their bid electronically and may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bids electronically, should deposit the cost of the bidding document in the Project's Rajaswa (revenue) account as specified below upon payment of a non-refundable fee of Nrs. 5,000 till 2080-10-14 on or before 12:00 Noon.

- 7. Electronic bids must be submitted through PPMO's e-GP system <a href="www.bolpatra.gov.np/egp on or before 12:00">www.bolpatra.gov.np/egp on or before 12:00</a> Noon on 2080-10-14. Bids received after this deadline will be rejected.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2080-10-14, 1:00 PM at the office of Yangwarak Rural Municipality, Tharpu, Panchthar. Bids must be valid for a period of 120 days after bid opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum of Nrs 8,00,000, which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
