Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system.
7. Online bids shall be opened in the presence of Bidders representatives who choose to attend on 28-04-2019 13:00 hours at the office of Yangwarak Rural Municipality, Panchthar Nepal. Online bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to NRs. 338000.0 which shall be valid for minimum 30 days beyond the bid validity period. The scanned copy of bid security should be uploaded in the e-GP system during bid submission.
